- The Stewardship Committee is taking the lead in a wellness survey which has been circulated.
- The Bishop reviewed the realignments of parishes; he is pleased with the progress to make this model successful.
- The Bishop introduced the new Lay Secretary, Jane Kirkpatrick.

# 8. Audit Committee Report

Peter Case, Colleen Lawrie

Presentation of the 2021 Consolidated Financial Statements (Audited)

Colleen Lawrie from the auditing firm Wilkinson & Company LLP reviewed the Auditor's report (distributed). After the standard statement of caveats, this is a "clean audit statement.". The Chair of the Audit Committee, Peter Case, spoke to the work of the Audit Committee. This includes review of draft statements of revenue and expenditures, projections, accounts receivable and payable; private interviews with management and the auditors; final review and sign off the statement. Peter thanked his committee members Frank Milne and Mary Hague Bishop Michael expressed his thanks and appreciation to the Audit Committee.

## 9. Synod Council – Governance and Responsibility

**Bishop** 

Bishop Michael thanked the Council for filling out the survey on behalf of Susan Graham Walker. He emphasized the need to talk about Council's role and responsibilities as a governing body, but also a role as an engaged community partner.

Moving forward, the conversations must be in person, so there may be a delay as we wait to get out of Covid. Following his meetings post Synod 2021 with the hubs, he has been thinking hard on who we as a diocese are moving forward. He cited projects already underway in the community\*, saying we need new ways to live our faith in the community. We are not able to do the same old, same old. The scheduled half day Visioning Day on Saturday, May 28<sup>th</sup> has been postponed.

\*New Ministry models Highlighted: St. Paul's Roslin and Christ Church Belleville under the leadership of Rev. Jeff O'Hare, Priest in Charge; St. John the Evangelist, Stirling and Parish of the Heart of Hastings, Rev. Canon Dr. Bob Wright, Priest in Charge; St. Matthew Marlbank and Trinity Parish, Rev. Dr. Ian Ritchie, Priest in Charge.

#### 10. Finance Update

DFO

Alex Pierson provided a summary of financial activity.

• There has been an offer made and accepted for St. Luke's Lyndhurst and Camp Hyanto. \$1m as is, where is. He noted that the cemetery does NOT belong to the Diocese.

- An offer for the former Finton Church has been accepted
- In Adolphustown, working with BAO on the cemetery situation.
- Healing Fund Tithe is on pause pending the appointment of a new National Indigenous Archbishop.
- Looked at Parish Receivables 10-year trend. Given what we've faced since 2020, we are
  in a fairly strong position. Alex highlighted the top receivables over \$20,000 and
  indicated those parishes were getting on top of the debts.

## Proposal – St. Mary Magdalene Picton Abeyance Account

St Mary Magdalene Abeyance Account: The account was established at a time of downturn.

Be it Resolved that Synod Council approves the proposed agreement with the Parish of St Mary Magdalene, Picton to clear the Abeyance Account and to support the forward ministry and financial stability of the Parish. The Financial Officer is directed to provide matching forgiveness (dollar for dollar) for payments by St Mary Magdalene Church against this account, up to \$8500. Funds withdrawn by the church to make this payment will be considered non-assessable for the purposes of CMM.

#### **AMP**

Wayne Varley: It is good to have our committees and groups report to Council on a regular basis. DOORS is receiving many applications from refugees and has had to declare a moratorium so that they can deal with applications already in process. A successful application was made to hire a student for the summer. The Diocese of Ontario had provided support and is looking for ways to assist DOORS outside of financial support.
