He deconsecrated St John's, New Dublin. He thanked profusely the Diocesan office staff especially Wendy Pierson.

8. Report from the Green Committee

Ian Ritchie distributed a report (available on Share site). There was a request that some action be taken by Synod Council to encourage parish reporting of energy use, as per Synod motion. We became aware that at least 2 parishes did submit the requested data and were not recorded as doing so.

9. St. Paul's, Loughborough Parish Marmora Agreement Dan Eustace, Bishop

Warden Dan Eustace presented information in support of a request consent to sever 4336 Sydenham Mill Street Sydenham int o 2 parcels of land in order for the rectory to be sold, and the net proceeds from the sale transferred to St. Paul's for the purpose of redeveloping the church into St. Paul's Centre. There are 6 phases too the proposed project. The Bishop reminded the Council that under the Canons of the Diocese, the proceeds from any property sale go into the Ministry Fund; 10% is immediately transferred to Indigenous ministry, and an assessment is made as to how much may go to other ministry or needs. St. Paul's will need to apply with a business plan to receive the remaining proceeds for their project. Alex Pierson estimates that it will cost c.\$100,000 to get the property ready for sale. After discussion the following motion was passed:

MOTION: by Aveleigh Kyle and Cathy Seymour that be it resolved that Council proceed to sever 4336 Sydenham Mill Street, Sydenham, Ontario from the St. Paul's Church property. CARRIED

The Bishop provided background on the Memorandum of Understanding between St. Paul's Church, Marmora and Habitat for Humanity, dated December 31, 2023. There are a number of issues with the MoU given St. Paul's financial situation. No action was mandated at this time.

Wayne reported that 5 Reach and Stretch grants have been processed. There is an October 1 deadline for further Reach grants; Stretch grant 2024 money has been fully committed.
